# Subject content

In this subject, students will learn about:

#### Module 1: Basic mathematics

- Basic mathematical operations with whole numbers, decimals and fractions
- Ratios and rates
- Percentages
- Metric system
- Graphs and data

#### Module 2: Mathematical calculations in health care

- Oral medications dosage: tablets and mixtures
- IV fluid management rate of flow, drop factor, burettes, pumps
- Injections types, mixing solutions, calculating dosage
- Paediatrics determine body surface area, dosage by body weight, verifying safe dosages by comparison with recommendations
- Volumes/rates calculating complex volumes using the metric system, oral, parenteral and intravenous medications

# Mode of delivery

This subject is taught on a face-to-face basis and includes six hours of classes per week. In addition, students are required to access vUWS regularly to download additional learning material, and to check for any announcements about the subject that may be posted there.
